

Release and Waiver of Liability for Cacao Ceremonies, Cacao Priest/ess Certification & Cacao Retreats

This is a Release and Waiver of Liability (the “Release”) between you and Seven Sisters Mystery School, LLC, a Massachusetts limited liability company, together with its successors, assigns and affiliates (the “Company” or “Seven Sisters Mystery School”). The term “you” refers to the enroller, purchaser and/or participant (“you”) in the cacao ceremony and/or certification course and/or retreat associated with this registration (the “Event”).

By participating in the Event and by your signature below, you agree and consent to the following:

ASSUMPTION OF RISK: If you are registering for a cacao ceremony with the Company, you have read and understood the “*Is Cacao Right for You?*” information on this [this page](#). If you are registered for the “*Become the Ceremonial Cacao Priestess or Priest*” Program with the Company, or for any retreat with the Company that includes the consuming of cacao, you have read and understood the “*Self-Care with Cacao*” section on the “*How to Work with Cacao*” [webpage](#). You are taking responsibility for your health and you release the Company from any liability for any unwanted effects you may have from ingesting cacao. You hereby choose to accept the risks of cacao in order to utilize the Company’s services. These services are of such value to you that you accept the physical and emotional risks of ingesting cacao, including but not limited to, raised heart rate, raised level of consciousness, and any further effects arising therefrom, in order to utilize the Company’s services. Alternatively, you have the option to refrain from ingesting cacao but still participate in any ceremony associated with the Event.

PHYSICAL AND PSYCHOLOGICAL HEALTH DISCLOSURE AND AGREEMENT:

a. By agreeing below, you truthfully declare that:

You have NO health or psychological conditions that might affect my participation in the cacao ceremony.

a. By agreeing below, you truthfully declare that:

You have NO current or previous heart conditions (including, but not limited to, heart attack, irregular or rapid heartbeat, pacemaker).

Or, if you DO have a current or previous heart condition, you will be refraining from ingesting cacao.

a. By agreeing below, you truthfully declare that:

You are NOT taking MAOI-based antidepressants.

Or, if you are taking MAOI-based antidepressants, you will consult your medical provider before ingesting cacao, and during any ceremony associated with the Event, you will start by only ingesting half of the ceremonial dose indicated in the preparation instructions and use your own judgement and discretion as to whether to ingest more.

WAIVER OF LIABILITY: You hereby forever release and waive your right to bring suit against the Company and its owners, officers, directors, managers, officials, trustees, agents, employees, or other representatives in connection with cacao related to utilizing the Company's services. You understand that this waiver means you and your successors give up your right to bring any claims, including but not limited to, personal injury, wrongful death, or property loss, or any other loss, including but not limited to claims arising from negligence, and give up any claim you may have to seek damages, whether known or unknown, foreseen or unforeseen.

EFFECTIVE DATE: You agree this Release and Waiver of Liability is effective immediately and this release is complete and forever.

GOVERNING LAW & SEVERABILITY: This Agreement will be governed by Massachusetts law, without regard to principles of conflicts of law. If any part of this Agreement is invalid or unenforceable or in conflict with the law of any controlling jurisdiction, that provision will be severed from this Agreement and the validity of the remaining provisions will not be affected.

I HAVE CAREFULLY READ AND FULLY UNDERSTAND ALL PROVISIONS OF THIS RELEASE, AND FREELY AND KNOWINGLY ASSUME THE RISK AND WAIVE MY RIGHTS CONCERNING LIABILITY AS DESCRIBED ABOVE.
